# Annual Report on Travel, Hospitality and Conferences Expenditures for the Fiscal Year 2017-2018

As required by the Treasury Board *Directive on Travel, Hospitality, Conference and Event Expenditures*, this report provides information on the total annual expenditures for each of travel, hospitality and conference fees for the Canadian Dairy Commission (CDC) for the fiscal year ending July 31, 2018. It also provides the variance explanations from the previous fiscal year in each of these areas.

This information is updated annually and does not contain information withheld under the *Access to Information Act*or the *Privacy Act*.

Expenditures on travel, hospitality and conference fees incurred by the CDC are for the most part related to activities that support the organizational mandate and the government's priorities. For the CDC, this includes coordinating federal and provincial dairy policies and creating a control mechanism for milk production which would help stabilize producer revenues and avoid milk surpluses. To pursue its mandate, the CDC works with provincial governments and dairy industry stakeholders such as dairy producers, processors, further processors and consumers. On behalf of the dairy industry, it administers the revenue and market pooling agreements and develops, implements, and administers major programs such as the Special Milk Class Permit Program, the Dairy Innovation Program, the Dairy Marketing Program and the Milk Access for Growth Program.

### Significant variances compared with previous fiscal year

The CDC manages travel, hospitality, and conference expenses with prudent stewardship and probity, and monitors its travel activities in order to meet its mandate and strategic objectives.

The expenses on travel, hospitality and conferences in the financial year ended July 31, 2018 are comparable expenses incurred in the financial year ended July 31, 2017. The main variances are explained as follows:

#### Travel:

Compared with fiscal year 2016-2017, the travel expenditures increased by \$27K. This mainly attributable to the increase in travel expenses related to operational activities.

#### Hospitality:

Hospitality expenditures decreased by \$11K compared with fiscal year 2016-2017. This was mainly because there were more meetings held in 2016-2017.

#### Conference fees:

Conference fees expenditures are relatively the same when compared to fiscal year 2016-2017.
